Understanding the Apprenticeship Levy

Tax paid via PAYE - monthly

Wage bill of more than £3M

0.5% (minimum £15,000 pa) Service Account via GOV.uk

Spent on apprenticeship provision per month

Funding bands

2% of employers

24 months returned to the Treasury

Recruitment & upskill existing staff

Minimum apprenticeship wage

Non-levy payers have co-investment at 95% / 100% if below age 19 & less than 50 employees

How to effectively use the Levy



Identify
current &
future needs
& identify skills
gaps of the
organisation



Identify which apprenticeship standards could fill these gaps



Manage your Levy funds, find training providers for the Standards in scope, advertise vacancies



Review skills of existing employees, use training needs analysis, advertise internally perhaps with information sessions

Use it or lose It!

Over £3 billion unused Levy – funds that can be used to train & develop employees in a variety of job roles

Could this be a lack of understanding & knowledge about how the Levy works?

Levy funds expire 24 months after the date submitted - unused funds will default back to the government
